7 **Nation in accordance with Sections 2 and 3 of Article X of the Enrollment**  
8 **Ordinance.**


9 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH.**

13 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
14 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
15 **of the Act of June 18, 1934 (48 Stat. 984).**
