5 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**  
6 **recognize that the above-named person(s) have relinquished their membership in**  
7 **this Nation, and does hereby order that their name(s) be deleted from the**  
8 **membership roll.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
11 **of MAY, 2001 at a meeting at which a quorum was present with a vote of 1,974.8 FOR; 190.7**  
12 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
13 **II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**  
14 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
15 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
16 **of June 18, 1934 (48 Stat. 984).**
