RESOLUTION NO. 01-199

1 **WHEREAS, the Tohono O'odham Nation, Department of Human Services is presently operating**
2 **the Division of Family Assistance, Food Distribution Program under an FY 2001 Grant**
3 **with the United States Department of Agriculture; and**

4 **WHEREAS, any amendments affecting the funding or funding levels of the grant shall be**
5 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

6 **WHEREAS, the Food Distribution Program has submitted the attached budget modification**
7 **#1/amendment #1 for review and approval. The budget modification/amendment**
8 **includes USDA reimbursement funds in the amount of \$1,224.00 for travel costs associated**
9 **with an Automated Inventory System (AIS) Planning meeting in Denver, Colorado; and to**
10 **transfer funds from other line items within the budget where additional funds are**
11 **needed.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13 **1. It hereby approves and authorizes budget modification #1/amendment #1 and**
14 **authorizes expenditures in accordance with the attached budget.**
- 15 **2. The Tohono O'odham Nation's Officials to wit: The Chairman and Vice-Chairman**
16 **and any designated official are hereby authorized to negotiate and execute the**
17 **grant.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
19 **of MAY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
21 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
