

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Bureau of Indian Affairs Social Services 638 Savings Carry Over; Authorization of Expenditures**  
**(Tohono O'odham Department of Human Services - Division of Family Assistance and Division**  
**of Child Welfare FY01 BIA 638 Supplement Budget Modification Number 1))**

**RESOLUTION NO. 01-200**

1 **WHEREAS, it was determined that the Bureau of Indian Affairs Social Services 638 contract had**  
2 **savings of \$80,418.00 in Administrative Funds and savings of \$2,048,128.16 in Welfare**  
3 **Assistance totaling \$2,128,546.16 from Fiscal Years 1997 through 1999; and**

4 **WHEREAS, through Resolution No. 2000-463 authorization was approved to utilize \$69,892.76 to**  
5 **off-set the Human Services Executive Office FY 01 Tribal Base Appropriations; and**  
6 **\$126,403.02 to be used to temporarily off-set the Social Service' FY 01 Tribal Base**  
7 **Appropriation totaling \$196,295.78; and**

8 **WHEREAS, the Tohono O'odham Department of Human Services is presently operating the**  
9 **Divisions of Family Assistance and Child Welfare Divisions through an approved**  
10 **FY01BIA 638 Supplement Budget; and**

11 **WHEREAS, a budget modification has been submitted and an additional amount of \$32,850.47**  
12 **is requested to include Indirect Cost line which was not included in the original**  
13 **budget. The modification includes the reclassification of a TWEP Specialist position**  
14 **to an Administrative Assistant position and modifies other line items; and**

15 **WHEREAS, the original amount requested was \$196,295.78 and with the increased amount of**  
16 **\$32,850.47 brings the new total to \$229,146.25.**

17 **NOW ,THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **authorizes and approves:**

19 **1. The increased amount requested from the carry over savings of \$32,850.47 for**  
20 **Indirect Costs; and the modifications which include the reclassification and**  
21 **modifying other line items per the attached FY 2001 Division of Family**  
22 **Assistance and Division of Child Welfare BIA 638 Supplement Budget**  
23 **modification Number 1.**

24 **2. The Tohono O'odham Nation's Officials to wit: The Chairman and Vice-Chairman**  
25 **and any designated official are hereby authorized to negotiate and execute the**  
26 **grant.**
