(To Accept the Libri Foundation's Books for Children Grant and

RESOLUTION NO. 01-202

1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia  
2 Library and Archives, the library agency of the Tohono O'odham Nation.

3 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the  
4 Library's application to the Libri Foundation's Books for Children grant for the  
5 amount of \$1,050.00 to provide recent and outstanding books for younger children,  
6 supported in part (\$350.00) by the Friends of the Library, an informal group.

7 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council accepts this Books for  
8 Children for the amount of \$1,050.00 and authorizes the use of this grant and  
9 authorizes the Venito Garcia Library and Archives to spend the funds provided.


10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH.

14 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
16 Stat. 984).
