

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Appointment of O'odham Charitable Advisory Board Member**  
**Myra Lawson)**

RESOLUTION NO. 01-215

1 WHEREAS, a special election was held on June 28, 1997 on the "O'odham Voice on the Use of  
2 Gaming Revenue" Initiative ("Initiative"); and

3 WHEREAS, the Initiative was approved by a majority of voters and provided for the creation of  
4 "an 11 member Board (1 member from each District) to establish an O'odham  
5 Charitable Organization (OCO) on the reservation"; and

6 WHEREAS, it is necessary to fill the OCO Board's San Lucy District seat with a candidate to  
7 complete the term of Edith Ortiz; and

8 WHEREAS, the Vice-Chairman of the Nation together with the Rules Committee interviewed  
9 qualified candidate Myra Lawson; and

10 WHEREAS, the Rules Committee now recommends the appointment of Ms. Lawson to complete  
11 the term of Ms. Edith Ortiz.

12 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby appoints Myra Lawson of  
13 the San Lucy District to the OCO Board to complete Edith Ortiz's term.


14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day  
15 of MAY, 2001 at a meeting at which a quorum was present with a vote of 1,730.8 FOR; -0- AGAINST;  
16 434.7 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (b)  
17 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
18 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
