

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the San Xavier District to Apply to the Greater Arizona**  
**Development Authority ["GADA"] for a Technical Assistance Grant)**

**RESOLUTION NO. 01-219**

- 1 **WHEREAS, the San Xavier District of the Tohono O'odham Nation has a need to file an**  
2 **application with GADA for Technical Assistance for a Capital Improvement Plan and**  
3 **all its subcategories; and**
- 4 **WHEREAS, the amount of the Technical Assistance grant request is \$15,000 and the San Xavier**  
5 **District would contribute \$10,880.69 in the form of in-kind services; and**
- 6 **WHEREAS, in Chapter 208 of the Laws of 1997 ("the Act"), the Arizona Legislature established the**  
7 **Greater Arizona Development Authority ("GADA") and authorized GADA, among other**  
8 **things, to provide technical assistance to political subdivisions, special districts,**  
9 **Indian Tribes, and tribal subdivisions through staff or other professional assistance**  
10 **in connection with the development or financing of infrastructure; and**
- 11 **WHEREAS, A.R.S. § 41-1554.05 defines technical assistance as including assistance in selecting**  
12 **outside consultants, evaluation of design and construction options, financial**  
13 **advisory services and assistance in satisfying statutory requirements; and**
- 14 **WHEREAS, A.R.S. § 41-1554 (6) defines "infrastructure" as " any facility located in this state for**  
15 **public use owned by a political subdivision, special district or Indian tribes that**  
16 **retains ultimate responsibility for its operation and maintenance"; and**
- 17 **WHEREAS, applicants for technical assistance must file applications in accordance with the**  
18 **requirements of the Act and of rules promulgated by GADA; and**
- 19 **WHEREAS, A.R.S. § 41-1554.04 (H)(3) requires that applications for technical assistance include**  
20 **a resolution from the governing body of the political subdivision, special district or**  
21 **Indian tribe that the project is in the best interests of the residents; and A.A.C. R20-**  
22 **8-102 (D)(3) requires in addition that the applicant state the estimated economic**  
23 **impact on the community; and**
- 24 **WHEREAS, the San Xavier District has met all of the above requirements with the exception of**  
25 **a support resolution from the Tohono O'odham Council which is being requested**  
26 **today; and**
- 27 **WHEREAS, the San Xavier District is exercising it's inherent authority to handle matters of local**

1 concern as outlined in Sec. 5, Article IX, "District Council Organization", of the  
2 Tohono O'odham Constitution.

3 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Council hereby supports and  
4 approves the San Xavier District to submit a grant application to the Greater Arizona  
5 Development Authority for technical assistance, pursuant to Title 41, Chapter 10,  
6 Article 8, Arizona Revised Statutes.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day  
8 of MAY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;  
9 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (j) of  
10 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
11 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
12 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
