2		the Year 03 (FY 2001) budget at \$536,566 for the Community Based Diabetes Program
3		and approved its name change to the <u>Healthy O'odham Promotion Program</u> ; and
4	WHEREAS,	the Tohono O'odham Department of Health and Human Services, Healthy O'odham
5		Promotion Program is requesting to modify its Year 03 Budget by adding \$370,215.35
6		in grant carry-over monies from Year 02 (FY 2000) for a total of \$906,781 to cover
7		anticipated costs for extending the Healthy O'odham Promotion Program through
8		September 30, 2001; and
9	WHEREAS,	to improve services for the Tohono O'odham Nation, the Healthy O'odham Promotion
10		Program requests approval to include new line items; and
11	WHEREAS,	to synchronize itself with the Nation's fiscal year and accounting system, the Healthy
12		O'odham Promotion Program requests to change its fiscal year from a June through
13		May fiscal calendar to the Nation's standard October through September fiscal
14		calendar.
15	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
16		1. Approves the Healthy O'odham Promotion Program modified Year 03 by adding
17		\$370,215.35 in grant carry-over monies from Year 02 (FY 2000) for a total of
18		\$906,781 to cover anticipated costs for continuing the Healthy O'odham
19		Promotion Program; and
20		2. Approves to include new line items; and
21		3. Approves the Healthy O'odham Promotion Program request to change its fiscal
22		year from a June through May fiscal calendar, to the Nation's standard October
23		through September fiscal calendar, so as to synchronize itself with the Nation's
24		accounting system; and
25		4. Approves the Healthy O'odham Promotion Program request to extend its FY 2000
26		budget period through September 30, 2001 to accommodate a fiscal year change.
