

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Year 03 Diabetes Data Improvement Grant Budget Modification #1
(June 1, 2000 - September 30, 2001))

RESOLUTION NO. 01-223

1 **WHEREAS, by Resolution Number 2000-183, the Tohono O'odham Legislative Council approved**
2 **the Year 03 (FY 2001) budget for the Diabetes Data Improvement Project**
3 **(administrated by the Healthy O'odham Promotion Program) at \$47,313.00; and**

4 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Healthy O'odham**
5 **Promotion Program requests to modify its Year 03 Budget by adding \$201,747.00 in**
6 **grant carry-over monies from Year 02 (FY 2000) for a total of \$249,060.00 to cover**
7 **anticipated costs for implementing the Diabetes Data Improvement Project; and**
8 **extending the Diabetes Data Improvement Project through September 30, 2001; and**

9 **WHEREAS, to synchronize itself with the Nation's accounting system, the Diabetes Data**
10 **Improvement Project (administrated by the Healthy O'odham Promotion Program)**
11 **requests to change its fiscal year from a June through May fiscal calendar to the**
12 **Nation's standard October through September fiscal calendar.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 14 **1. Approves the Diabetes Data Improvement Project modified Year 03 Budget, to add**
15 **new line items and by adding \$201,747.00 in grant carry-over monies from Year**
16 **02 (FY 2000) for a total of \$249,060.00 to cover anticipated costs for implementing**
17 **the project; and**
- 18 **2. Approves the Diabetes Data Improvement Project request to change its fiscal year**
19 **from a June through May fiscal calendar, effective October 1, 2001 so as to**
20 **synchronize itself with the Nation's accounting system; and**
- 21 **3. Approves the Diabetes Data Improvement Project request to extend its FY 2000**
22 **budget period through September 30, 2001 to accommodate a fiscal year change.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
24 **of MAY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
26 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
