

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2001 Department of Human Services Division of Alcohol/Substance Abuse Program**  
**Account #10-1407 - Budget Modification #1)**

RESOLUTION NO. 01-224

1 WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating  
2 the Division of Alcoholism and Substance Abuse Program Component under P.L. 93-  
3 638 Master Health Contract with the Public Health, Indian Health Services; and

4 WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance  
5 Abuse Program of non-recurring funds of \$9,011.86 made available by modification  
6 number 56 and carryovers from Account 10-1407 from fiscal years 1996 to 1999 of  
7 \$500,769.99. Of the carryovers \$107,889.30 will be used, and \$9,011.86 made available  
8 by modification number 56. This budget modification is submitted for review and  
9 approval by the Department of Human Services.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- 11 1. Hereby approve and authorize expenditures in accordance with the attached  
12 budget modifications submitted by the Department of Human Services.
- 13 2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman  
14 and any designated official are hereby authorized to negotiate and execute the  
15 contract.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day  
17 of MAY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;  
18 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
19 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
20 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
21 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


