

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment of \$100,000.00 to Advocate Program's
FY 2001 budget line item 01.1035.810)

RESOLUTION NO. 01-226

1 **WHEREAS, the Advocate Program utilizes private attorneys to serve as conflict attorneys to**
2 **provide legal advice and assistance to its clients; and**
3 **WHEREAS, the Advocate Program was awarded \$84,292.00 in its FY 2001 operating budget for**
4 **professional services (line item 01.1035.810) which includes the payment of fees and**
5 **expenses of its conflict attorneys; and**
6 **WHEREAS, the Nation contracted with David M. Juarez, Lawrence O. Boswell and David K. Kovalik**
7 **to serve as conflict attorneys for the Advocate Program during FY 2001; and**
8 **WHEREAS, each Attorney's FY 2001 contract provides for maximum funding of \$27,000.00 for the**
9 **period October 1, 2000 through September 30, 2001; and**
10 **WHEREAS, it is estimated that approximately \$100,000.00 in additional funding shall be required**
11 **to compensate Attorneys for their fees and expenses for the remainder of FY 2001; and**
12 **WHEREAS, the Nation will provide \$100,000.00 from its general fund to supplement the Advocate**
13 **Program's operating budget line item 01.1035.810 (Professional Services) to address**
14 **the estimated cost of funding conflict attorney services for the remainder of FY 2001.**
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the additional appropriation of \$100,000.00 from the Nation's general fund**
17 **to be transferred to the Advocate Program's FY 2001 budget line item 01.1035.810.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
19 **of MAY, 2001 at a meeting at which a quorum was present with a vote of 1,503.5 FOR; 662.0**
20 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
