6 **recognize that the above-named person(s) have relinquished their membership in**  
7 **this Nation, and does hereby order that their name(s) be deleted from the**  
8 **membership roll.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
10 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,302.15 FOR; -0- AGAINST;**  
11 **115.35 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Article II,**  
12 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**  
13 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
14 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
15 **18, 1934 (48 Stat. 984).**
