

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Suspending Article XII, Section 3(K)(2) of the Legislative Rules with Regard to
Membership on the Appropriations Committee)

LEGISLATIVE ORDER NO. 01-278

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**
2 **and procedures to regulate its standing committees, boards and special committees**
3 **pursuant to the Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)**
4 **and (b); and**

5 **WHEREAS, the Legislative Council has exercised this authority by adopting Legislative Council**
6 **Rules (Rules) in 1987 to govern committee powers, creation, functions, and,**
7 **specifically, the eligibility requirements for membership on Legislative Committees**
8 **(Rules Article XI and XII); and**

9 **WHEREAS, the Appropriations Committee was created as a standing committee of the Legislative**
10 **Council after the Legislative Rules' adoption (Legislative Order No. 136-90, passed**
11 **May 7, 1990); and**

12 **WHEREAS, Article XII, Section 3(K)(2) of the Rules states that "[a] Legislative Representative may**
13 **serve on 3, but no more than 3, legislative committees"; and**

14 **WHEREAS, the Legislative Council's past practice and custom has been to exempt Appropriations**
15 **Committee membership from the Rule prohibiting membership on no more than 3**
16 **committees; and**

17 **WHEREAS, it is necessary to continue this practice in order to allow the thirteen (13) existing**
18 **Legislative Committees to seat five members as described in the committee plans of**
19 **operation.**

20 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
21 **suspends Article XII, Section 3(K)(2) of the Rules with regard to membership on the**
22 **Legislative Council Appropriations Committee.**

23 **BE IT FINALLY ORDERED by the Tohono O'odham Legislative Council that this Order shall be**
24 **effective immediately upon passage by a majority vote of the Legislative Council as**
25 **defined in the Legislative Rules.**
