

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Tohono O'odham Legislative Council Committee Meeting Schedule
(Thru May 2003))

LEGISLATIVE ORDER NO. 01-303

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**
3 **to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**
5 **Committee Meeting Schedule for the 2001-2002 and 2002-2003 Legislative Sessions;**
6 **and**

7 **WHEREAS, the Rules Committee, in accordance with the newly-established committee**
8 **memberships, has developed a "Tohono O'odham Legislative Council Committee**
9 **Meeting Schedule (Thru May 2003)" and now recommends its adoption.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
11 **adopts the attached "Tohono O'odham Legislative Council Committee Meeting**
12 **Schedule (Thru May 2003)" presented by the Rules Committee.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH Day of**
14 **JUNE, 2001 at a meeting at which a quorum was present with a vote of 1,797.9 FOR; 458.9 AGAINST;**
15 **-0- NOT VOTING; and 160.7 [02] ABSENT, pursuant to the powers vested in the Council by Section**
16 **1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
19 **Stat. 984).**
