2		acquisition of title to land in trust, 25 CFR Part 151; and
3	WHEREAS,	the new administration of President Bush has ordered a delay in the effective date of
4		Part 151 in order to allow comment on whether the regulations should be withdrawn
5		in whole or in part or amended in whole or in part; and
6	WHEREAS,	the Tohono O'odham Nation seeks to restore its title to lands both within the current
7		boundaries of the Nation and outside the boundaries in order to consolidate its land
8		base, to protect cultural and sacred sites, to provide space for population growth, to
9		provide a designated land area for the Hia Ced O'odham, and for other purposes; and
10	WHEREAS.	the Legislative Council of the Tohono O'odham Nation strongly supports the
11	,	regulations as published and is opposed to further delays and amendments to the
12		regulations.
13	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14		comments of the Tohono O'odham Nation substantially in the form attached hereto
15		and authorizes and directs the Chairman of the Nation to submit these comments to
		the Department of the Interior on behalf of the Tohono O'odham Nation.
