

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a Proposal for a P.L. 93-638 Grant Agreement with the Bureau of Reclamation**  
**for Purchase of Equipment to Maintain and Operate the Water Distribution System at**  
**Schuk Toak Farm)**

RESOLUTION NO. 01-318

1 WHEREAS, the Tohono O'odham Nation ("Nation") is in the final stages of completing the  
2 construction of a distribution system for delivery of Central Arizona Project water to  
3 the Tohono O'odham Nation at the Schuk Toak Farm under Grant Agreement No. 6-  
4 FG-32-00100 with the Bureau of Reclamation; and

5 WHEREAS, the Nation is proposing a separate Grant Agreement with the Bureau of Reclamation  
6 in the amount of \$369,380.00 to finance the purchase of major equipment needed to  
7 maintain and operate the water distribution system at Schuk Toak Farm, which  
8 equipment will be made available for the use of the Tohono O'odham Farming  
9 Authority under a future agreement with the Nation.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the  
11 proposal for a Grant Agreement with the Bureau of Reclamation in the amount of  
12 \$369,380.00 to finance the purchase of major equipment needed to maintain and  
13 operate the water distribution system at Schuk Toak Farm, and authorizes the  
14 Chairman of the Nation to negotiate a final agreement, including the amount of the  
15 grant, with the Bureau of Reclamation and to execute the Grant Agreement and any  
16 other documents needed to implement this proposal.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
18 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;  
19 -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
20 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
