

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2002 Budget for the Title XX-Child Care)

RESOLUTION NO. 01-325

1 WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young
2 members by providing for their welfare through various programs and services
3 designed to meet their special needs; and

4 WHEREAS, the State Planned Social Services Block Grant-Title XX has awarded the Tohono
5 O'odham Nation a total of \$127,730.00; and

6 WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this program for
7 the benefit of its young members; and

8 WHEREAS, the Title XX-Child Care of the Tohono O'odham Nation has submitted for review and
9 approval the proposed Grant Year 2002 Funds.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council does
11 hereby approve the Title XX-Child Care Budget for FY 2002 in the amount of
12 \$127,730.00.

13 BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 2001 to
14 September 30, 2002.

15 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
16 Nation's Officials, to wit: the Chairman, and any designated officials are hereby
17 authorized to negotiate and execute the grant.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day
20 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
21 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
22 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
23 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
24 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


