

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Employment & Training - Department of Labor - Comprehensive Service Program Budget Program Year 2001)

RESOLUTION NO. 01-327

1 WHEREAS, the funding amount for the Department of Labor WIA PY 2001 Comprehensive Service
2 Program Budget is \$468,151.00; and

3 WHEREAS, the WIA Comprehensive Service Program has been approved for PY 2000 & 2001; and

4 WHEREAS, the reclassification of employment & training counselor and resource specialist has
5 been changed to case manager.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
7 approve the Department of Labor WIA PY 2001 - Comprehensive Service Program
8 Budget authorized for expenditure from July 1, 2001 until June 30, 2004 in the amount
9 of \$468,151.00.

10 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
11 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute
12 the contract, provided however, that any amendment affecting the funding or
13 funding levels of this contract shall be submitted for further prior approval by this
14 Council.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day
16 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,337.15 FOR; -0- AGAINST;
17 80.35 NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)
18 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
19 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
20 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
