RESOLUTION NO. 01-329

1 **WHEREAS, the funding amount for the State of Arizona, Department of Economic Security, - PY**
2 **2001 Administrative Cost Adult and Youth Program is \$12,817.00; and**

3 **WHEREAS, this budget will commence July 1, 2001 and will expire June 30, 2003; and**

4 **WHEREAS, this budget is designed to provide training and support services to eligible Tohono**
5 **O'odham members residing on the Tohono O'odham Nation.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
7 **approve the State of Arizona - Department of Economic Security - PY 2001**
8 **Administrative Cost Adult and Youth Program in the amount of \$12,817.00 authorized**
9 **for expenditure from July 1, 2001 until June 30, 2003.**

10 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation's Officials, to wit; the Chairman is**
11 **hereby authorized to negotiate and execute the contract, provided however, that any**
12 **amendment affecting the funding or funding levels of this contract shall be**
13 **submitted for further prior approval by this Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH, Day**
15 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
16 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
17 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


