**(Approval of the Tohono O'odham Nation Employment & Training – State of Arizona –**  
**Department of Economic Security – FY 2002 Administrative Adult Program)**

RESOLUTION NO. 01-332

1 **WHEREAS, the funding amount for the State of Arizona, Department of Economic Security, – FY**  
2 **2002 Adult Administrative Program is \$7,231.00; and**

3 **WHEREAS, this budget will commence October 1, 2001 and will expire June 30, 2003; and**


4 **WHEREAS, this budget is designed to provide training and support services to eligible Tohono**  
5 **O'odham members residing on the Tohono O'odham Nation.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
7 **approve the State of Arizona – Department of Economic Security – FY 2002 Adult**  
8 **Administrative Program in the amount of \$7,231.00 authorized for expenditure from**  
9 **October 1, 2001 until June 30, 2003.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
11 **Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute**  
12 **the contract, provided however, that any amendment affecting the funding or**  
13 **funding levels of this contract shall be submitted for further prior approval by this**  
14 **Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>. Day**  
16 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
17 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




