

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Nation Employment & Training – State of Arizona –**  
**Department of Economic Security – FY 2002 Adult Program)**

RESOLUTION NO. 01-333

1 WHEREAS, the funding amount for the State of Arizona, Department of Economic Security, – FY  
2 2002 Adult Program is \$92,972.00; and

3 WHEREAS, this budget will commence October 1, 2001 and will expire June 30, 2003; and

4 WHEREAS, this budget is designed to provide training and support services to eligible Tohono  
5 O'odham members residing on the Tohono O'odham Nation; and

6 WHEREAS, this budget reflects reclassification of positions established within the program from  
7 employment & training counselor and resource specialist to case manager.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
9 approve the State of Arizona – Department of Economic Security – FY 2002 Adult  
10 Program in the amount of \$92,972.00 authorized for expenditure from October 1,  
11 2001 until June 30, 2003.

12 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
13 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute  
14 the contract, provided however, that any amendment affecting the funding or  
15 funding levels of this contract shall be submitted for further prior approval by this  
16 Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup> Day  
18 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,337.15 FOR; -0- AGAINST;  
19 80.35 NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)  
20 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


