5	resource specialist to case managers.
6	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
7	approve the Department of Health and Human Services – Native Employment Works
8	Program Year 2001 Budget authorized for expenditure from July 1, 2001 until June 30,
9	2002 in the amount of \$150,868.00.
10	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
11	Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute
12	the contract, provided however, that any amendment affecting the funding or
13	funding levels of this contract shall be submitted for further prior approval by this
14	Council.
