1 **WHEREAS, the funding amount for the State of Arizona - Department of Economic Security -**
2 **Administrative Cost Pool Program Year 1999 has been identified for carry over funds**
3 **in the amount of \$6,922.00; and**


4 **WHEREAS, this budget will commence upon approval of this resolution and will expire June 30,**
5 **2002.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
7 **approve the State of Arizona - Department of Economic Security - Administrative Cost**
8 **Pool Program Year 1999 Budget authorized for expenditure from July 1, 2000 until**
9 **June 30, 2002 in the amount of \$6,922.00.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
11 **Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute**
12 **the contract, provided however, that any amendment affecting the funding or**
13 **funding levels of this contract shall be submitted for further prior approval by this**
14 **Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
16 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
17 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
