

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Employment & Training - State of Arizona-
Department of Economic Security - Adult Budget Program Year 1999)**

RESOLUTION NO. 01-336

1 **WHEREAS, the funding amount for the State of Arizona - Department of Economic Security -**
2 **Adult Budget Program Year 1999 has been identified for carry over funds in the**
3 **amount of \$25,096.00; and**

4 **WHEREAS, this budget will commence upon approval of this resolution and will expire June 30,**
5 **2002; and**

6 **WHEREAS, this budget will purchase a program vehicle to provide services throughout the**
7 **Tohono O'odham Nation.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
9 **approve the State of Arizona - Department of Economic Security - Adult Program Year**
10 **1999 Budget authorized for expenditure from July 1, 2000 until June 30, 2002 in the**
11 **amount of \$25,096.00.**

12 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
13 **Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute**
14 **the contract, provided however, that any amendment affecting the funding or**
15 **funding levels of this contract shall be submitted for further prior approval by this**
16 **Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
18 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (h) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


