

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2002 Parenting Skills Training Program Contract Proposal
- July 01, 1999 to June 30, 2003)

RESOLUTION NO. 01-340

1 WHEREAS, the Tohono O'odham Department of Human Services has the primary responsibility
2 to provide prevention and intervention services to families at risk for child abuse and
3 neglect; and

4 WHEREAS, the Arizona Department of Economic Security provides funds for the development
5 and administration of child abuse and neglect prevention programs under specified
6 terms and conditions; and

7 WHEREAS, Parenting Training has been identified as one means of preventing child abuse and
8 neglect; and

9 WHEREAS, the Tohono O'odham Department of Human Services has submitted an FY 2002
10 proposal for Parenting Skills, and that the term of this contract shall be for four (4)
11 years to commence on July 01, 1999 and end on June 30, 2003 in accordance with
12 Resolution No. 99-108 and the third year budget from July 01, 2001 to June 30, 2002 is
13 hereby submitted for review and approval.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Tohono
15 O'odham Nation's Officials to wit: the Chairman, Vice Chairman and any designated
16 official are hereby authorized to negotiate and execute the contract.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day
18 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
19 -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
20 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
21 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


