**(FY 2002 Elderly Title III B, C-1 and C-2 and Cash in Lieu of Commodities (CILC) Budget,**  
**July 01, 2001 - June 30, 2002)**

**RESOLUTION NO. 01-344**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**  
4 **Title III of the Older American's Act of 1965 as amended, through the Administration**  
5 **of the Inter-Tribal Council of Arizona; and**

6 **WHEREAS, the services provided to elderly members has been beneficial and services continue**  
7 **to be necessary to provide nutritional and social support; and**

8 **WHEREAS, the Elderly Program has prepared a proposal for FY 2002 Title III funding to provide**  
9 **nutritional and social support services to eligible elderly members.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

11 **1. That it hereby approves the proposal for Title III funding for the Elderly Program**  
12 **to continue to provide such services it has proposed per attachments in light of**  
13 **the requirements and regulations:**

14 **1. Title III-B in the amount of \$69,912**

15 **2. Title C-1 in the amount of \$66,175**

16 **3. Title C-2 in the amount of \$6,843**

17 **4. Cash in Lieu of Commodities (CILC) in the amount of \$5,378**

18 **2. That the Nation has been informed by Inter-Tribal Council on Aging that the**  
19 **budget period for FY 2002 will be from July 01, 2001 through June 30, 2002.**

20 **3. That the Tohono O'odham Nation officials, to wit: The Chairman is hereby**  
21 **authorized to negotiate and execute the grant, provided however, that any**  
22 **amendments affecting the funding or funding levels of this contract shall be**  
23 **submitted for further prior approval by this Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup> Day**  
25 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,323.35 FOR; 94.15**  
26 **AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section**  
27 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
