

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Title III Grant Amendment/One-Time Funding ending June 30, 2001)**

RESOLUTION NO. 01-345

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**
4 **Title III of the Older American's Act of 1965 as amended, through the Administration**
5 **of the Inter-Tribal Council of Arizona; and**

6 **WHEREAS, the services provided to elderly members has been beneficial and services continue**
7 **to be necessary to provide nutritional and social support; and**


8 **WHEREAS, the Elderly Program has recently awarded a one-time Grant Amendment for fiscal year**
9 **2001 which ends June 30, 2001. A budget modification has been prepared to enhance**
10 **and improve nutritional and social support services to eligible Elders.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 12 **1. That it hereby reviews the budget modification for Title III one-time Grant**
13 **Amendment increase of \$21,456.00 to be spent in accordance to the prepared**
14 **budget modification specifications.**
- 15 **2. That the Nation has been informed by Inter-Tribal Council on Aging that this**
16 **budget period for this grant will end on June 30, 2001.**
- 17 **3. That the Tohono O'odham Nation officials: The Chairman is hereby authorized**
18 **to negotiate and execute the grant, provided however, that any amendments**
19 **affecting the funding or funding levels of this contract shall be submitted for**
20 **further prior approval by this Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
22 **of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
24 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
