RESOLUTION NO. 01-347

1 WHEREAS, the Tohono O'odham Department of Human Services is presently operating the
2 Administrative Support Unit through approved Tribal funding; and

3 WHEREAS, a budget modification/amendment has been submitted which does not change the
4 funding level but establishes a line item and modifies other line items.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby
6 approves the attached FY 2001 Administrative Support Unit budget as reflected in the
7 attached budget.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day
9 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
10 -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)
11 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
12 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
13 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
