

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Cultural Center/Museum Site Selection Procedure)

DEFEATED
LEGISLATIVE ORDER NO. 01-349

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to protect and**
2 **preserve the historic and cultural resources of the Tohono O'odham Nation pursuant**
3 **to Section 1(c)(8) of Article VI and Sections 1 and 2(d) of Article XVIII of the**
4 **Constitution of the Tohono O'odham Nation ("Constitution"); and**

5 **WHEREAS, the Legislative Council has exercised these powers by approving a \$15,191,080 budget**
6 **for the planning, design, construction, staffing and operations of a Cultural Center/**
7 **Museum (Legislative Council Resolution No. 2000-275, approved June 16, 2000); and**

8 **WHEREAS, two resolutions to select a Museum Site were presented to the Legislative Council by**
9 **the Museum Committee but were defeated (Legislative Council Resolutions No. 2000-**
10 **548 and No. 01-025, defeated November 21, 2000 and January 10, 2001, respectively);**
11 **and**

12 **WHEREAS, the Museum Committee subsequently selected the following three sites for final**
13 **consideration by the Legislative Council: Baboquivari Site, Sunrise Hill Site, and**
14 **Pisinemo Site; and**

15 **WHEREAS, on May 8, 2001, three additional resolutions to select a Museum site were defeated**
16 **(Legislative Council Resolution No. 01-192, 01-193, 01-194); and**

17 **WHEREAS, the Cultural Preservation Committee, having oversight of matters pertaining to the**
18 **Cultural Center/Museum, recommends that the Legislative Council adopt the**
19 **attached "Culture Center/Museum Site Selection Procedure" to provide an equitable**
20 **process for selecting the Museum Site; and**

21 **WHEREAS, the Rules Committee and the Legislative Council have reviewed the Culture**
22 **Center/Museum Site Selection Procedure.**


23 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
24 **adopts the Cultural Center/Museum Site Selection Procedure, which shall govern the**
25 **Legislative Council's process for selecting the Museum Site.**
