

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Submission and Negotiation of the Fiscal Year 2002 Annual Funding Agreement
to the Indian Self-Determination Act Master Contract with the Indian Health Service)**

RESOLUTION NO. 01-352

1 WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2 Indian Health Service pursuant to the authority conferred to the Nation by the Indian
3 Self-Determination Act, as amended; and

4 WHEREAS, the Tohono O'odham Nation desires to continue operation of such functions and
5 commence operation of certain new programs, functions, services, and activities
6 currently performed by the Indian Health Service, including the Diabetes Model.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the Chairman
8 of the Nation is authorized to submit the attached Fiscal Year 2002 Annual Funding
9 Agreement to the Indian Health Service, including the Diabetes Model, and to
10 negotiate maximum funding and acceptance by the Indian Health Service of the
11 terms and conditions contained therein.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day
13 of JUNE, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
14 -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
15 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
16 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
17 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


