
1 **WHEREAS, the following named person(s) have formally relinquished their membership in the**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
7 **recognize that the above-named person(s) have relinquished their membership in**
8 **this Nation, and does hereby order that their name(s) be deleted from the**
9 **membership roll.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
11 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,094.1 FOR; -0- AGAINST;**
12 **323.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article II,**
13 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**
14 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**


