


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sif-Oidak District Fiscal Year 2001-2002 Budget)

RESOLUTION NO. 01-373

1 WHEREAS, the Sif-Oidak District Council approved their Fiscal Year 2002 Budget at a meeting
2 held on June 27, 2001; and
3 WHEREAS, on July 10, 2001, the Sif-Oidak District presented their Fiscal Year 2002 budget
4 request in the amount of \$1,144,330.00 to the Tohono O'odham Legislative Council for
5 their approval; and
6 WHEREAS, the Sif-Oidak District does have sufficient funds in their own account to implement
7 the budget amount requested.
8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports
9 and approves the FY 2002 Sif-Oidak District budget in the amount of \$1,144,330.00.
10 BE IT FURTHER RESOLVED that the Sif-Oidak District is authorized to expend their FY 2002 budget
11 from August 01, 2001 to July 31, 2002.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day
14 of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
15 -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)
16 & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
19 Stat. 984).
