(Approving the request of Sif-Oidak District Supplemental Funds in the amount  
of \$500,000.00)**

**RESOLUTION NO. 01-374**

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to Resolution No. 01-235**  
2 **appropriated supplemental funds for each of the eleven districts in the amount of**  
3 **\$500,000.00; and**

4 **WHEREAS, the Sif-Oidak District supported the Supplement Funds, as approved by Resolution**  
5 **No. 02-01-03, and as presented to this Council; and**

6 **WHEREAS, the Sif-Oidak District by District Resolution No. 02-01-03 and budget proposal is**  
7 **requesting the funds in the amount of \$500,000.00.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports**  
9 **and approves the request to utilize the supplemental funds as outlined in the budget.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
11 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
12 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
13 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
14 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
15 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
16 **Stat. 984).**




