RESOLUTION NO. 01-379

1 **WHEREAS, the Fire Department/Department of Public Safety has taken over Operations of the**
2 **Wildland Program from Bureau of Indian Affairs and will continue to operate the**
3 **program indefinitely; and**

4 **WHEREAS, funding in the amount of \$209,629.19 has been provided by BIA Wildland PL-93-638**
5 **cost contract for the operation of the Wildland Program; and**

6 **WHEREAS, this funding is to be utilized to provide emergency services in the saving of lives,**
7 **property and protection of natural resources and wildlife to the members of the**
8 **Tohono O'odham Nation; and**

9 **WHEREAS, the Fire Department/Department of Public Safety request approval of the attached**
10 **Budget Modification #1 for the Wildland Program PL-93-638 FY 2001; and**


11 **WHEREAS, the appropriated funding will be distributed into the FY 2001 existing line items; and**

12 **WHEREAS, the request of approved Budget Modification #1 has been reviewed by the appropriate**
13 **committees.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2001 Budget Modification #1 for the Wildland Program PL-93-638 Budget in the**
16 **amount of \$466,040.91.**

19 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**

21 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


