

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Child Care Services/Title XX Fiscal Year 2001 Budget Amendment,
Resolution No. 2000-503, July 1, 2000 - June 30, 2001)

RESOLUTION NO. 01-381

1 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**
2 **members by providing for their welfare through various programs and services**
3 **designed to meet special needs; and**

4 **WHEREAS, the Child Care Services Program has been successfully operated through the Division**
5 **of Early Childhood Development and has served many Tohono O'odham children;**
6 **and**

7 **WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this program for**
8 **the benefit of its young members; and**

9 **WHEREAS, the Child Care Services has prepared a budget amending FY 2001 Title XX from**
10 **\$145,988.00 to \$127,730.00, which reflects a decrease in the amount of \$18,258.00**
11 **awarded to the program to be expended accordingly.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the amended Child Care Services - Title XX Budget for FY 2001 in the amount**
14 **of \$127,730.00 and authorizes the expenditure of funds as described in the State**
15 **Contract.**

16 **BE IT FURTHER RESOLVED that the duration of the budget will be from July 01, 2000 to**
17 **June 30, 2001.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's Officials, to wit: the Chairman, and any designated officials are hereby**
20 **authorized to negotiate and execute the contract, provided however, that any**
21 **amendments affecting the funding levels of the contract shall be submitted for prior**
22 **approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
24 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of**
26 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


