(Approving the \$333,333.35 Set-A-Side Budget for the Schuk Toak District Communities)**

**RESOLUTION NO. 01-386**

1 **WHEREAS, the Schuk Toak District Council held a special meeting on June 26, 2001 with a quorum**  
2 **present; and**

3 **WHEREAS, the Schuk Toak District Council does realize there is a real need to request from the**  
4 **Tohono O'odham Nation savings from Gaming funds for unmet needs for the**  
5 **communities; and**

6 **WHEREAS, the \$500,000.00 allocation would be very beneficial to the Schuk Toak District**  
7 **members; and**


8 **WHEREAS, the funds will be placed with the Everen Security Account to be utilized for the purpose**  
9 **of meeting the needs for the communities.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**  
11 **approve:**


- 12 **1. The amount of \$333,333.35 allocation, covering communities of Sil Nakya, San**  
13 **Isidro, Comababi, Pan Tak, Garcia Strip and Santa Rosa Ranch at \$55,555.55 each,**  
14 **for the Schuk Toak District to carry on and take care of their community needs as**  
15 **specified in their Community Set-A-Side Budgets.**
- 16 **2. The remaining amount of \$166,666.65 covering communities of Fresno, Queens**  
17 **Well and San Pedro will not be disbursed until approval of their budgets.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
19 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 1,917.75 FOR; 499.75**  
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**
