

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tribal Representation for the Tucson Area Representatives to**  
**the Tribal Leaders Diabetes Committee)**

RESOLUTION NO. 01-389

- 1 **WHEREAS, the Tribal Leaders Diabetes Committee (TLDC) is a non-profit organization**  
2 **representing all federally recognized tribes in the United States in advocating for the**  
3 **improvement of diabetes care and prevention among American Indians; and**
- 4 **WHEREAS, the Tribal Leaders Diabetes Committee was created by the Director of the U.S. Indian**  
5 **Health Service (IHS) as an advisory committee to the IHS in matters related to the**  
6 **Special Diabetes Programs for Indians (SDPI); and**
- 7 **WHEREAS, the SDPI was appropriated through the Balanced Budget Act of 1997; and**
- 8 **WHEREAS, the SDPI was expanded through the Federal Spending Act of 2000; and**
- 9 **WHEREAS, the Tribal Leaders Diabetes Committee members and alternates represent each of the**  
10 **twelve Indian Health Service Areas, and are generally appointed at large by tribal**  
11 **governmental officials within each Area; and**
- 12 **WHEREAS, since 1997 the Tohono O'odham Nation has had a representative to serve on the Tribal**  
13 **Leaders Diabetes Committee; and**
- 14 **WHEREAS, Rosemary Lopez is serving as the member to the TLDC representing the Tucson Area;**  
15 **and**
- 16 **WHEREAS, traditionally, the members of the TLDC are elected tribal leaders; and**
- 17 **WHEREAS, at the recommendation of the Department of Human Services and the concurrence**  
18 **of the Health and Human Oversight Committee, as elected official Mr. Albert Manuel,**  
19 **Jr. has been recommended to be the Tucson Area representative to the TLDC and**  
20 **Barbara Salvicio as the alternate Tucson Area representative to the TLDC.**
- 21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**
- 22 **1. Recommends and approves Albert Manuel, Jr. as the Tucson Area representative**  
23 **to the TLDC and Barbara Salvicio as the alternate.**
  - 24 **2. Requests that Dr. Michael Trujillo, Director of the Indian Health Service, and**  
25 **that TLDC recognize Albert Manuel, Jr. as the official Tucson Area representative**  
26 **and Barbara Salvicio as the alternate.**
- 27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
28 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of**


