

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the Utility Cost Pool; Transfer of funds from Employee Compensation
and the Annual Leave Reserve)**

RESOLUTION NO. 01-394

1 **WHEREAS, the Tohono O'odham Legislative Council, in adopting the Executive Branch FY 2001**
2 **Budget provided funds for the Utility Cost Pool, (Pool), administered by the General**
3 **Support Services (GSS); and**

4 **WHEREAS, the GSS has determined that the Pool will require additional funds for the remainder**
5 **of the current fiscal year; and**

6 **WHEREAS, the GSS has prepared and presented the attached budget amendment to provide for**
7 **additional funds to the Pool from the Employee Compensation Reserve and the Annual**
8 **Leave Reserve; and**


9 **WHEREAS, the amendments were reviewed by the Budget and Finance Committee and the**
10 **Committee recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
12 **approve of the attached budget amendments as presented by the General Support**
13 **Services, in that:**

- 14 **1. The budget for the Annual Leave Reserve is decreased in the amount of \$90,000.00,**
15 **and that the sum is authorized to be transferred to the Utility Cost Pool;**
- 16 **2. The budget for the Employee Compensation Reserve is decreased in the amount**
17 **of \$90,000.00, and that the sum is authorized to be transferred to the Utility Cost**
18 **Pool; and**
- 19 **3. The budget of the Utility Cost Pool is amended in the total amount of \$180,000.00.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
21 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,302.15 FOR; -0- AGAINST;**
22 **115.35 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1**
23 **(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
