

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Final Fiscal Year 2001 Allocation of Annual Funding Agreement to the Indian Self-Determination Act Master Contract with the BUREAU OF INDIAN AFFAIRS)**

RESOLUTION NO. 01-397

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs pursuant to the authority conferred to the Nation by the**
3 **Indian Self-Determination Act, as amended; and**

4 **WHEREAS, the Bureau of Indian Affairs has determined that the Economic Development**
5 **Department's Final Allocation for fiscal year 2001 to be \$233,920.00; and**

6 **WHEREAS, the Final Allocation for the Economic Development Department replaces the**
7 **previously allocated amount for the program.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the Credit and Finance**
9 **budget that includes the Final Allocation for the Economic Development Department**
10 **as determined by the Bureau of Indian Affairs for fiscal year 2001.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
12 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
13 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
14 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




