1	WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2	Bureau of Indian Affairs pursuant to the authority conferred to the Nation by the
3	Indian Self-Determination Act, as amended; and
4	WHEREAS, the Bureau of Indian Affairs has determined that the Economic Development
5	Department's Final Allocation for fiscal year 2001 to be \$233,920.00; and
6	WHEREAS, the Final Allocation for the Economic Development Department replaces the
7	previously allocated amount for the program.
8	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the Credit and Finance
9	budget that includes the Final Allocation for the Economic Development Department
10	as determined by the Bureau of Indian Affairs for fiscal year 2001.
11	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11 TH . Day
12	of <u>IULY</u> , <u>2001</u> at a meeting at which a quorum was present with a vote of <u>2,417.5</u> FOR; <u>-0-</u> AGAINST;
13	-0-NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
14	Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
15	Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
16	(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
