

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract for Tohono O'odham Tribal Employment Rights
Commission)**

RESOLUTION NO. 01-400

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**
2 **1978 and has successfully met the needs of the Tohono O'odham Nation; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to**
4 **eradicate employment discrimination within the exterior boundaries of the Tohono**
5 **O'odham Nation; and**

6 **WHEREAS, the Tohono O'odham Legislative Council reviewed and approved Tohono O'odham**
7 **Tribal Employment Rights Commission FY 2001 Budget Amendment No. 1 for legal**
8 **representation in the amount of \$20,000.00; and**

9 **WHEREAS, the Tribal Employment Rights Commission comes before the Legislative Council**
10 **seeking approval to appoint Dan Press, Esq. to work with the Tribal Employment**
11 **Rights Commission regarding the San Xavier Mission case and updating the Tribal**
12 **Employment Rights Ordinance 01-85.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **approves the attorney contract.**

15 **BE IT FURTHER RESOLVED that the funding amount for this contract will be pursuant to**
16 **Resolution No. 01-072.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
18 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 1,856.9 FOR; 560.6**
19 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
