RESOLUTION NO. 01-405

1 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 01-390, "Approving**
2 **the Tribal Representation for the Tucson Area Representatives to the National Indian**
3 **Health Board"; and**

4 **WHEREAS, Resolution No. 01-390 approves Councilman Alex Ramon to serve as the Tucson Area**
5 **Representative to the NIHB and Ruben Howard from the Pascua Yaqui Tribe as the**
6 **alternate representative; and**

7 **WHEREAS, questions regarding Mr. Howard's name being included in the resolution were raised;**
8 **and**

9 **WHEREAS, the Director of Department of Human Services did meet with Chairman Manuel**
10 **regarding Resolution No. 01-390 and he recommended to rescind the resolution and**
11 **introduce a new resolution.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby rescinds**
13 **Resolution No. 01-390, "Approving the Tribal Representation for the Tucson Area**
14 **Representatives to the National Indian Health Board."**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
16 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0- AGAINST;**
17 **160.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
18 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
