RESOLUTION NO. 01-407

1 **WHEREAS, the Tohono O'odham Nation is currently providing medically necessary**
2 **transportation to members and residents of the Nation, collecting any and all third**
3 **party reimbursements where applicable; and**

4 **WHEREAS, there is a need to add line items for Gas, Oil & Coolants and Repair & Maintenance -**
5 **Vehicles to the base budget; and**

6 **WHEREAS, the Division of Health Transportation Service has modified the FY 2001 base budget**
7 **to add these line items to cover over expenditure for Gas, Oil & Coolants and Repair &**
8 **Maintenance Vehicles; and**


9 **WHEREAS, budget modification #2 has been submitted for review and approval by the**
10 **Department of Human Services for the Division of Health Transportation Service.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approves:**

- 13 **1. The attached budget modification #2 to the FY 2001 Health Transportation Service**
14 **budget.**
- 15 **2. Establishment of budget line items for Gas, Oil & Coolants and Repair &**
16 **Maintenance - Vehicles.**
- 17 **3. The Tohono O'odham Nation Officials to wit: the Chairman and Vice Chairman**
18 **and any designated Official are hereby authorized to negotiate and execute the**
19 **contract and expend funds associated with this budget.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
21 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**
23 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


