(Approval of the Tohono O'odham Nation Employment & Training - Arizona  
Department of Economic Security (ADES) - Welfare to Work (WtW) FY 1998 -  
Budget Modification #3)**

**RESOLUTION NO. 01-413**

1 **WHEREAS, ADES notified the Nation funds for the Welfare to Work program the contract would**  
2 **be extended for another 2 years; and**

3 **WHEREAS, this budget modification and contract amendment extends the end date from August**  
4 **11, 2001 to August 11, 2003; and**

5 **WHEREAS, this program is designed to assist clients from welfare dependency to self-sufficiency.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
7 **approve the Arizona Department of Economic Security - Welfare to Work Budget FY**  
8 **1998 budget modification #3 and contract amendment to extend the expiration date**  
9 **to August 11, 2003.**

10 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
11 **Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute**  
12 **the contract, provided however, that any amendment affecting the funding or funding**  
13 **levels of this contract shall be submitted for further prior approval by this Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> Day**  
15 **of JULY, 2001 at a meeting at which a quorum was present with a vote of 2,098.3 FOR; -0- AGAINST;**  
16 **-0- NOT VOTING; and 319.2 [11] ABSENT, pursuant to the powers vested in the Council by Section**  
17 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
20 **Stat. 984).**
