

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 2001 Tohono O'odham Department of Human Services-Family Preservation  
Budget Modification #1)**

**RESOLUTION NO. 01-424**

1 **WHEREAS, an additional allocation of \$55,232.00 was received for the Family Preservation**  
2 **Program for FY01 from the Bureau of Indian Affairs; and**

3 **WHEREAS, the Family Preservation Program provides training for staff for family centered**  
4 **services as well as preventive approaches to families in crises; and**

5 **WHEREAS, the Tohono O'odham Department Human Services is presently operating the Division**  
6 **of Child Welfare, Family Preservation Program through an approved FY01 BIA 638**  
7 **Budget; and**

8 **WHEREAS, a budget modification has been submitted to reflect the additional allocated amount**  
9 **of \$55,232.00; and**

10 **WHEREAS, the budget modification has been submitted for review and approval by the Family**  
11 **Preservation Program.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13           **1. It hereby approves and authorizes expenditures in accordance with the attached**  
14           **budget modification submitted by the Department of Human Services.**
- 15           **2. The Tohono O'odham Nation's Officials to wit, the Chairman, Vice Chairman and**  
16           **any designated officials are hereby authorized to negotiate and execute the**  
17           **contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
19 **of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 160.7 [05] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**




