RESOLUTION NO. 01-425

1 **WHEREAS, The Tohono O'odham Nation Department of Human Services is presently operating**
2 **the Division of Alcoholism and Substance Abuse Program Component under P.L. 93-**
3 **638 Master Health Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance**
5 **Abuse Program of non-recurring funds of \$16,436.68 made available by modification**
6 **number 54 and carryovers from Account 10-1406 from fiscal years 1996 to 1999 of**
7 **\$1,176,900.37, of the carryovers \$113,969.92 will be used, and \$16,436.68 made**
8 **available by modification number 54. This budget modification is submitted for**
9 **review and approval by the Department of Human Services.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 11 **1. It hereby approves and authorizes expenditures in accordance with the attached**
12 **budget modification submitted by the Department of Human Services.**
- 13 **2. The Tohono O'odham Nation's Officials to wit, the Chairman, Vice Chairman and**
14 **any designated officials are hereby authorized to negotiate and execute the**
15 **contract.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
17 **of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and 160.7 [05] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat. 984).**






