5	WHEREAS, Grants and Contracts identified a duplication of FY-95/96 savings amount in the
6	previous calculation; and
7	WHEREAS, the carryover savings should have reflected \$48,846.70 for FY-1999 instead of
8	\$213,135.48; and
9	WHEREAS, Grants and Contracts has since identified FY-2000 savings of \$5,434.10, bringing
10	cumulative savings amount to \$54,280.80; and
11	WHEREAS, though Modification No. 83 to the 93-638 Master Contract, the Bureau of Indian Affairs
12	has awarded the Gila River Adjudication Program \$50,000.00 for FY-2001.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14	amending Resolution No. 01-076 to reflect \$48,846.70 in savings for FY-1999 and
15	approves the inclusion of the total cumulative savings amount of \$54,280.80 and the
16	\$50,000.00 for FY-2001 for a total amount of \$204,280.80 in accordance with attached
17	budget amendment.
