

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Rescinding Resolution No. 80-88, "Adoption of Domestic Affairs Committee's**  
**Plan of Operation")**

RESOLUTION NO. 01-430

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules  
2 and procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees pursuant to the Constitution of the  
4 Tohono O'odham Nation, Article VI, Section 1(a); and

5 WHEREAS, in 1988 the Legislative Council did adopt a Plan of Operation for the Domestic Affairs  
6 Committee pursuant to Resolution No. 80-88, "Adoption of Domestic Affairs  
7 Committee's Plan of Operation"; and

8 WHEREAS, the Domestic Affairs Committee has recently developed an Updated Plan of Operation  
9 to reflect its powers, oversight authority, membership, meetings, and other matters;  
10 and

11 WHEREAS, the Rules Committee has reviewed the updated Domestic Affairs Plan of Operation and  
12 recommends its adoption; and

13 WHEREAS, because the Domestic Affairs Committee's updated Plan of Operation will replace the  
14 plan adopted pursuant to Resolution No. 80-88, it is necessary to rescind Resolution  
15 No. 80-88.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
17 rescinds Resolution No. 80-88, "Adoption of Domestic Affairs Committee's Plan of  
18 Operation."

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day  
20 of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
21 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
22 Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
23 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat. 984).


