

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of \$10,000.00 from Indian Health Service for Health Needs Assessment
Survey Being Administered by the Department of Human Services)**

RESOLUTION NO. 01-432

1 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 99-519 on**
2 **September 27, 1999, which supported the executive staff to conduct a Focus Study and**
3 **Health Assessment; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 99-520 which**
5 **supported the Tri National Fair on October 15, 1999; and**

6 **WHEREAS, the Indian Health Services funded \$15,000.00 and \$22,500.00 respectively to assist in**
7 **the Health Assessment and Focus Study; and**

8 **WHEREAS, once again the Indian Health Service has appropriated one-time funding of \$10,000.00**
9 **to the Tohono O'odham Nation for assistance of the Health Assessment; and**

10 **WHEREAS, the Health Assessment survey has started in the O'odham communities in Mexico and**
11 **will be administered on the Tohono O'odham reservation; and**


12 **WHEREAS, Indian Health Service has agreed to support efforts of the Health Assessment through**
13 **Modification 60.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council;**

- 15 **1. Has reviewed and approved the Indian Health Service allocation of \$10,000.00**
16 **with the attached budget.**
- 17 **2. The Tohono O'odham Nation's Officials to wit; the Chairman and Vice Chairman**
18 **and any designated official are hereby authorized to negotiate and execute the**
19 **contract, effective May 28, 2001.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
21 **of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
