

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Jonas Robles to the Tohono O'odham Ki:Ki Association Board
of Directors)**

RESOLUTION NO. 01-438

1 **WHEREAS, the Council did enact Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:ki**
2 **Association" ("Ki:ki Association Ordinance"), thereby establishing the Ki:ki Association**
3 **and its five member Board of Directors; and**

4 **WHEREAS, Article 5, Section 1(a) of the Ki:ki Association Ordinance provides that "The Board shall**
5 **consist of five (5) voting members appointed by the Tohono O'odham Legislative**
6 **Council . . . The Board members' service will be for a period of 4 years, and will be**
7 **appointed in such a manner that the term of service is staggered."; and**

8 **WHEREAS, in order to stagger the Board members' terms as required, it is necessary to make an**
9 **exception to Article V, Section 1(a) for the limited purpose of allowing a Board member**
10 **to serve a term shorter than four (4) years in length; and**

11 **WHEREAS, the Tohono O'odham Legislative Housing Committee has oversight over housing**
12 **matters and did interview the Board of Director candidates; and**

13 **WHEREAS, there is an emphasis on the continuation of Ki:ki Association's overall goals and**
14 **objectives and the importance of a smoother transition; and**

15 **WHEREAS, the Legislative Housing Committee recommends the appointment of Jonas Robles to**
16 **the Tohono O'odham Ki:Ki Association Board of Directors effective upon approval and**
17 **ending February 10, 2005.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
19 **hereby appoint Jonas Robles to the Tohono O'odham Ki:Ki Association Board of**
20 **Directors to replace interim Board Member Rita Martinez effective upon approval and**
21 **ending February 10, 2005.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
24 **of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; 160.7**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
